

# WARRANTY PARTS RETURN SHIPPING INSTRUCTIONS

- The Warranty AFA Claim Number(s) must be indicated on the carrier's shipping document.
- All shipments must include a hard copy of the Warranty Claim Form (AFA).
- All warranty parts must be individually tagged with the AFA number, genuine P/N, Vehicle Identification Number (VIN), quantity and date.
- The outside of all boxes must have labels clearly indicating the final destination.
- All warranty parts must be kept at your location and consolidated into one shipment per week.
- All warranty parts must be safely packaged to avoid any transportation damages.
